



ADDENDUM TO CONDITIONS OF ENTRY - COVID-19 SPECIFIC CONDITIONS OF RETURN TO ON CAMPUS LEARNING AND LIVING, TERM 4 - 2020

1. Parents and/or legal guardians (**Parents**) of all students returning to Geelong Grammar School (the **School**) for on campus learning and living, acknowledge and accept the following COVID-19 Specific Conditions in addition to the School's Conditions of Entry (as published).
2. The engagement of Parents with our **COVID-19 specific Conditions of Return to On Campus Learning and Living** is required to support the School to actively mitigate the risk of infection and the potential of reinfection cycles.
3. **RETURN TO ON CAMPUS LEARNING AT TOORAK AND BOSTOCK HOUSE**
 - 3.1. Parents acknowledge there will be restrictions imposed upon their access to the School and they will follow the direction of the School as to arrangements for the safe and staggered arrival and exit of students from the School.
 - 3.2. Parents acknowledge they will follow the direction of the School regarding required hygiene practices and spatial distancing requirements. Particularly, parents will not congregate at the commencement or end of the School day in breach of continuing community restrictions.
 - 3.3. Parents acknowledge that if the student has symptoms consistent with a flu-like illness, the student will need to be collected as soon as able by their Parents and isolated off campus. Management of the student's illness will be coordinated by the School Nurse in consultation with the Senior Medical Officer and Parents.
 - 3.4. Parents acknowledge they will be required to complete and submit the **Daily COVID-19 Health Questionnaire** before the student's arrival at School each day.
 - 3.5. Parents acknowledge that the School will take the temperature of the student upon arrival at School each day and if the student's temperature is recorded to be 37.5°C or higher, the student will be unable to attend School on that day.
 - 3.6. Students are strongly encouraged to have their flu vaccine and provide the School with confirmation of the date of receipt of the flu vaccine.
 - 3.7. Parents of students with complex medical needs are encouraged to seek medical advice from their treating medical practitioner to support informed risk assessment and decision-making regarding the suitability of return to campus for the student. A decision for return to learning on campus will need to be made in conjunction with the Senior Medical Officer.
 - 3.8. Parents and students (as age appropriate) are strongly encouraged to download the COVIDsafe app to assist with contact tracing measures.
4. **RETURN TO ON CAMPUS LEARNING AND LIVING AT TIMBERTOP**
 - 4.1. Parents acknowledge that the student will be required to undergo a COVID-19 test at Timbertop. If the student returns a positive COVID-19 test result, the student will be quarantined and will need to be collected as soon as able by their Parents or 'COVID Emergency Contact'. Parents will meet all costs associated with the COVID-19 testing of the student.
 - 4.2. Overseas students returning to Timbertop will be required to comply with both Federal and State Government requirements for quarantine upon arrival in Australia. Parents will be required to meet all additional costs associated with such quarantine requirements.
 - 4.3. Parents of students with complex medical needs are encouraged to seek medical advice from their treating medical practitioner to support informed risk assessment and decision-making regarding the suitability of return to Timbertop for the student. A decision for return to learning and living on campus will need to be made in conjunction with the Senior Medical Officer.
 - 4.4. Parents acknowledge there will be restrictions imposed upon their access to Timbertop and they will follow the direction of the School for arrangements for the safe and staggered arrival and exit of students from the Timbertop campus.
 - 4.5. Parents acknowledge that the student's health will be monitored daily and the School will take the temperature of the student each morning and if the student's temperature is recorded to be 37.5°C or higher, the student will be required to attend at the Timbertop Health Care Centre for observation.
 - 4.6. Parents acknowledge that it is a condition of the student's continuing enrolment at the School that the Parents shall ensure, and accept responsibility for, the student's compliance with the School's Rules and Policies. Parents acknowledge that the student will be removed from Timbertop for the remainder of Term 4 should the student intentionally not follow the direction of the School regarding required hygiene and spatial distancing requirements and requirements as to the wearing of face masks.
 - 4.7. Parents acknowledge that the student will be unable to leave Timbertop until the conclusion of Term 4 save for medical appointments where attendance by the student will be coordinated by the School.
5. **BOARDING STUDENTS - RETURN TO ON CAMPUS LEARNING AND LIVING AT CORIO**
 - 5.1. Parents acknowledge that boarding students will be required to undergo a COVID-19 test following arrival at



Corio. If the student returns a positive COVID-19 test result, the student will be quarantined and will need to be collected as soon as able by their Parents or 'COVID Emergency Contact'. Parents will meet all costs associated with the COVID-19 testing of the student.

- 5.2. Parents acknowledge that if the student has symptoms consistent with a flu-like illness, the student will need to be collected as soon as able by their Parents or 'COVID Emergency Contact' and isolated off campus. Management of the student's illness will be coordinated by the Kennedy Health Centre in consultation with the Senior Medical Officer and Parents. The student will be unable to return to campus without provision of a negative COVID-19 test result.
- 5.3. Overseas boarding students returning to Corio will be required to comply with both Federal and State Government requirements for quarantine upon arrival in Australia. Parents will be required to meet all additional costs associated with such quarantine requirements.
- 5.4. Parents of boarding students with complex medical needs are encouraged to seek medical advice from their treating medical practitioner to support informed risk assessment and decision-making regarding the suitability of return to Corio for the student. A decision for return to learning and living on campus will need to be made in conjunction with the Senior Medical Officer.
- 5.5. Parents acknowledge there will be restrictions imposed upon their access to Corio and they will follow the direction of the School for arrangements for the safe and staggered arrival and exit of boarding students from the School.
- 5.6. Parents acknowledge that there will be restricted access to the Corio campus throughout Term 4.
- 5.7. Parents acknowledge boarding students will be required to complete and submit the **Daily COVID-19 Health Questionnaire** before breakfast each day.
- 5.8. Parents acknowledge that the boarding student's health will be monitored daily and the School will take the temperature of the student each morning and if the student's temperature is recorded to be 37.5°C or higher, the student will be required to attend at the Kennedy Health Centre for observation. Management of the student's illness will be coordinated by the Kennedy Health Centre in consultation with the Senior Medical Officer and Parents.
- 5.9. Parents acknowledge that it is a condition of the boarding student's continuing enrolment at the School that the Parents shall ensure, and accept responsibility for, the student's compliance with the School's Rules and Policies.
 - 5.9.1. Parents acknowledge that the boarding student will be subject to a requisite suspension should the student intentionally not follow the direction of the School regarding required hygiene and spatial distancing requirements and requirements as to the wearing of face masks.
 - 5.9.2. Parents acknowledge that the boarding student will be subject to a requisite suspension should the

student arrange for a third party to attend at the School without the consent of the School. This includes but is not limited to the delivery of food and groceries to the Corio campus but does not include items delivered through usual postal and courier services.

- 5.10. Parents and boarding students are strongly encouraged to download the COVIDsafe app to assist with contact tracing measures.

6. DAY STUDENTS - Return to on campus learning at Corio

- 6.1. Parents acknowledge that day students will be required to undergo a COVID-19 test on return to School at Corio. If the student returns a positive COVID-19 test result, the student will be quarantined and will need to be collected as soon as able by their Parents. Parents will meet all costs associated with the COVID-19 testing of the student.
- 6.2. Day students returning to Corio are strongly encouraged to have their flu vaccine. Parents acknowledge that if the student has symptoms consistent with a flu-like illness, the student will need to be collected as soon as able by their Parents and isolated off campus.
- 6.3. Parents acknowledge they will be required to complete and submit the **Daily COVID-19 Health Questionnaire** for the Year 5 and Year 6 day students before the student's arrival at School each day.
- 6.4. Parents acknowledge the Year 7 to Year 12 day students will be required to complete and submit the **Daily COVID-19 Health Questionnaire** before the student's arrival at the Corio campus each day.
- 6.5. Parents acknowledge that the School will take the temperature of the day student upon arrival at School each day and if the student's temperature is recorded to be 37.5°C or higher, the student will be unable to attend School on that day.
- 6.6. Parents of day students with complex medical needs are encouraged to seek medical advice from their treating medical practitioner to support informed risk assessment and decision-making regarding the suitability of return to Corio for the student. A decision for return to learning on campus will need to be made in conjunction with the Senior Medical Officer.
- 6.7. Parents acknowledge there will be restrictions imposed upon their access to Corio and they will follow the direction of the School for arrangements for the safe and staggered arrival and exit of day students from the School.
- 6.8. Parents will follow the direction of the School regarding required hygiene practices and spatial distancing requirements. Particularly, parents will not congregate at the commencement or end of the School day in breach of continuing community restrictions.
- 6.9. Parents acknowledge that it is a condition of the day student's continuing enrolment at the School that the Parents shall ensure, and accept responsibility for, the student's compliance with the School's Rules and Policies.



- 6.9.1. Parents acknowledge that the day student will be subject to a requisite suspension should the student intentionally not follow the direction of the School regarding required hygiene and spatial distancing requirements.

- 6.9.2. Parents acknowledge that the day student will be subject to a requisite suspension should the student arrange for a third party to attend at the School without the consent of the School. This includes but is not limited to the delivery of food to the Corio campus.

- 6.10. Parents and day students are strongly encouraged to download the COVIDsafe app to assist with contact tracing measures.
